1. SCOPE AND PURPOSE

1.1 SCOPE

This document contains the General conditions for the provision of PRISMA products, the Data License and the Project Form to be compiled by the user.

1.2 PURPOSE

Access to PRISMA mission data requires that the user register him/herselves through the PRISMA portal and compile and accepts the General conditions for the provision of PRISMA products and the PRISMA License. This can be done downloading the General conditions for the provision of PRISMA products and the License, which together define the terms and conditions for the access and usage of PRISMA data, reading them and compiling all the fields required in the Project Form, including personal information about Affiliated Users and Contractors/Consultants.

2. APPLICABLE AND REFERENCE DOCUMENTS

3.2 DEFINITIONS

Affiliated User	The natural or legal person sharing the Use of the ORIGINAL PRODUCT with the Main User within an activity jointly carried out.
Ancillary Data	Technical information related to the PRISMA system, included in the ORIGINAL Product.
Contractors and Consultants	The natural or legal persons, other than the User, the Main User and/or the Affiliated Users and/or the Commercial Team Users, that the User, the Main User and the Affiliated Users intend to avail themselves for the use of the ORIGINAL Product.
Commercial Team Users	The natural or legal persons sharing the Use of the ORIGINAL Product with the Main User for the generation and commercialization of the DERIVED Products.
DERIVED Product	Products generated by the users from an ORIGINAL Product after applying different processing and/or addition on methods and techniques that produce significant and irreversible modifications to the ORIGINAL Product so that its initial characteristics are no longer identifiable either in whole or in part.
ORIGINAL Product	It consists of the Level 1, 2B, 2C, 2D PRISMA System Product (containing the hyperspectral multi-band image and the panchromatic

Purposes of Use	Purposes for which the ORIGINAL Product can be used, falling within one or more thematic areas that the User will declare at the time of requesting the registration to the PRISMA system and selected among those listed by ASI.
Use	The use of the ORIGINAL Product that comprises Product installation, visualization, copying, processing (including DERIVED Product generation), printing, via web transmitting/receiving and storing in computers or in other devices.
User	The natural or legal person receiving and using the ORIGINAL Product, in compliance with the terms specified in these General Conditions, and thus becoming the License to Use holder.

4. GENERAL CONDITIONS FOR THE PROVISION OF PRISMA PRODUCTS

4.1 THE USER REGISTRATION

The delivery of the ORIGINAL Products is subject to the User / Main User registration on the PRISMA portal. The registration procedure shall require the User / Main User to (a) register itself by providing its personal data; (b) declare the Purposes of Use of the ORIGINAL Product; and (c) fill in the Project Form, including the personal data of any possible Contractor, Consultant, Affiliated User and Commercial Team User, where applicable. Following the registration procedures, a specific account will be assigned to the User / Main User. All personal data provided by the User / Main User shall be electronically stored by ASI, by the ASI contractors that implement the operational activities of the PRISMA system in the name and on behalf of ASI, including the user support; all personal data provided by the User shall be processed by the relevant national competent authorities. By requesting the ORIGINAL Products, the User / Main User acknowledges the characteristics of the ORIGINAL Products and the restrictions to which their provision and use may be subject to, as specified in these General Conditions and in the attached License to Use.

4.2 LOG-IN CREDENTIALS

The authorization to access to the PRISMA system is obtained when the system sends to the User / Main User the login credentials to be used for the assigned account.

4.3 LIMITATION OF WARRANTY

The ORIGINAL Products are complex in nature and therefore ASI shall in no way guarantee that they are free from any errors, anomalies or imperfections. The User / Main User acknowledges the foregoing and accepts that under no circumstances and any reason whatsoever ASI shall be held liable for any damage, loss of data or whatever else caused by the above-mentioned anomalies, errors or imperfections. By acknowledging the peculiarity and complexity of the ORIGINAL Products, the User / Main User accepts this ASI disclaimer of warranty.

4.4 PROCESSING OF PERSONAL DATA

All personal data provided by the User / Main User, shall be processed, also electronically, in accordance with the provisions of the applicable laws, and in particular, the EU Regulation 2016/679 of the European Parliament and the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data. Personal data and information provided by the User / Main User are processed for a maximum period of 15 years, at the end of which they are destroyed by ASI and/or the industrial contractors - specifically appointed by ASI as *Data Processors* pursuant to art. 28 of the aforementioned European Regulation - which carry out the operational activities of the PRISMA System and the user support in the name and on behalf of ASI. The purposes of the data processing are institutional and non-commercial and are the following: a) to allow the supply and management of the PRISMA system services (e.g. account management, request for acquisitions and Products, supply of information on the PRISMA system and its status); b) to enable the relevant national authorities to perform their functions and duties in compliance with the applicable legislation; c) to pursue advertising and promotion of the use of the PRISMA system and its Products. The *personal data Controller* shall be ASI, via del Politecnico s.n.c., Roma. Interested Parties may contact the *Data Protection Officer* (e-mail rdp@asi.it) to exercise the rights granted to them by Chapter III of the EU Regulation 2016/679.

4.5 FORCE MAJEURE

The User / Main User hereby acknowledges and accepts that the competent national authorities reserve the right to inhibit the availability of some ORIGINAL Products. Therefore, the User / Main User expressly accepts

that the delivery of the ORIGINAL Product may be prevented by the aforementioned inhibiting measures, and in no event ASI shall be held liable.

4.6 APPLICABLE LAW AND DISPUTES RESOLUTIONS

These General Conditions for the delivery of the ORIGINAL Products, the attached License to Use as well as any other circumstances pertaining or relating to them, shall be governed by the Italian law. The Parties undertake to solve amicably any possible dispute relating to the interpretation and/or application of the General Conditions for the supply of the ORIGINAL Products and the attached License to Use. Any dispute that cannot be settled amicably by the Parties shall be referred uniquely to the Court of Rome.

5. LICENSE TO USE

Article 1 - Parties

On the one side, the Agenzia Spaziale Italiana (Italian Space Agency - hereinafter also referred to as "ASI"), whose registered office is located in Via del Politecnico, s.n.c., 00133 Roma, and on the other side, the natural or legal person that required the access to the PRISMA system through the registration on the dedicated PRISMA portal (hereinafter also referred to as the "User / Main User").

Article 2 - Object of the License to Use

All the definitions contained in the General Conditions shall constitute an integral part of this License to Use. This License to Use confers to the User / Main User a non-exclusive right to use the ORIGINAL Product, for the Purposes of Use stated in the registration process, in accordance with this License to Use and the terms specified below. By accepting this License to Use, the User / Main User accepts the limitations on the use of the ORIGINAL Products provided for herein. The User or the Main User is responsible for ensuring the compliance with the terms and conditions of this License to Use also by any Contractor, Consultant, Affiliated User or Commercial Team User. Contractors and Consultants shall not be authorized to keep copies of the ORIGINAL Products nor to further use them once they have completed their contractual or consultancy activities. After the ORIGINAL Product delivery, ASI hereby reserves at any time the right to ask information concerning the ORIGINAL Product utilization, ensuring confidentiality of the information provided by the Main User. The User / Main User, the Affiliated User or any Commercial Team User, Contractor and Consultant shall not disclose, reproduce, transfer or make in any way available to third parties the information and any Ancillary Data supplied by ASI together with the ORIGINAL Product. The transfer in whole or in part of this License to Use or any of the hereto-related rights or granting of sub-licenses or similar assignments to third parties is explicitly prohibited without the prior written consent of ASI.

Article 3 - Intellectual Property Rights

The ORIGINAL Products referred to in this License to Use are property of ASI. The ORIGINAL Products are protected by the Italian and international copyright laws; moreover, raw data acquired by the PRISMA satellite or anyway stored in the ASI archives are protected by the regulations concerning database protection under Directive EU 96/9 dated 11th March 1996, adopted in the Italian law system by the Legislative Decree no. 169 dated 6th May 1999. The User / Main User hereby acknowledges the ASI copyright over the ORIGINAL Products and commits itself to reproduce the copyright notice irrespective of the supporting device of the ORIGINAL Product, as follows:

"PRISMA Product - © Italian Space Agency (ASI) (year of acquisition). All rights reserved".

Within the limits of its own business, the User / Main User hereby guarantees the respect of the ASI's intellectual property rights over the ORIGINAL Products and commits itself to notify promptly in writing to ASI of any unlawful use, including that of third parties, of the ORIGINAL Products supplied and processed under the terms of this License to Use.

Article 4 - Permitted Uses

Under the terms of this License, the use of the ORIGINAL Product is allowed only for the Purposes of Use stated by the User / Main User during the registration process and may consist in carrying out scientific research, research and development of new products, generation of DERIVED Products, applications and/or innovative prototypes or pre-operational services experimental/demonstrative activities, as well as tests, studies, analyses, for one or more thematic areas listed in the PRISMA License to Use.

Only the DERIVED Products can be used for commercial purposes. The use of the DERIVED Products for commercial purposes is only allowed to Users and Main Users who have an operating office in the Italian territory and are active in the field of remote sensing, and to all members of a group of Commercial Team Users whose Main User has the characteristics specified above.

Any User / Main User shall not acquire, as a result of its utilisation activities, any further right on the ORIGINAL Product other than those necessary to pursue the aforementioned Purposes of Use.

The User / Main User, as well as any Affiliated User or any Commercial Team User, undertake to inform ASI as soon as new products, DERIVED Products, as well as new applications or services to which intellectual property rights may be associated are developed in connection with the use of the ORIGINAL Product. Where

applicable, the User / Main User, the Affiliated Users, and any Commercial Team User, are authorized to mention their copyright on the data and information obtained as a result of the use of the ORIGINAL Product for the aforementioned Purposes of Use through the following notice:

“Product/Application/Service/Data/Information generated by ... under a license from ASI Original PRISMA Product - © Italian Space Agency (ASI) - (Year of acquisition)”

The User / Main User, the Affiliated Users and any Commercial Team User shall be authorized to copy the ORIGINAL Product only to achieve the purposes of the Use permitted under this License. The User / Main User, the Affiliated Users and any Commercial Team User shall be authorized upon information to ASI to (i) publish the ORIGINAL Product, without the Ancillary Data, on their website in jpeg or gif format, or (ii) to print it in hard copy for promotional purposes. In these cases, they undertake to mention the ASI's copyright on the ORIGINAL Product, in accordance with the provision of Art. 3 of this License to Use.

Article 5 - Prohibited Uses

Any use of the ORIGINAL Product other than those authorized by this License to Use shall be prohibited. In particular:

- (a) The User / Main User shall not reproduce, make available, disclose or distribute any ORIGINAL Products to any third party, except as provided for in Art. 2 and Art. 4 of this License to Use or under explicit authorization by ASI;
- (b) No use for commercial purposes of the ORIGINAL Product is allowed under the present License to Use;
- (c) It is not permitted to alter, modify or remove the copyright notice or any other detail attesting the ASI rights on the ORIGINAL Products.

Any conduct that is not in line with or is in violation of the provisions of this License to Use shall cause the interruption of the supply of the ORIGINAL Products to the User / Main User, the suspension or deactivation of the User's / Main User's account and the rejection of any pre-existing request for the supply of the ORIGINAL Products.

Article 6 – Guarantees and Limitation of Liability

The User / Main User and any Contractor and/or Consultant and/or Affiliated User and/or any Commercial Team User shall be responsible for any use of the ORIGINAL Products supplied by ASI; ASI is not responsible for the accuracy or suitability of the ORIGINAL Product for any particular use whatsoever. Therefore, the User / Main User shall not be entitled to present any claim against ASI for any loss and/or damage, direct or indirect, deriving from the use of the ORIGINAL Products.

Article 7 - Reports, publications and participation in conferences

The User / Main User:

- (a) is required to provide ASI with an annual report (max 500 words) on the use of the ORIGINAL and DERIVED Products and the results obtained from the relevant utilization activities, including any commercial use and/or application of DERIVED Products where applicable, as well as an updated list of all involved Affiliated Users, Contractors, Consultants, and Commercial Team Users;
- (b) shall be authorized to publish the results of the activities carried out in pursuing the aforementioned Purposes of Use and to present the results in national and international conferences, upon prior notification to ASI and mentioning in any publication the following notice: ***“Project carried out using ORIGINAL PRISMA Products - © Italian Space Agency (ASI); the Products have been delivered under an ASI License to Use”***.

Article 8 – Right of Termination and Extension

1. ASI is hereby entitled to immediately terminate this License to Use in case of an infringement of any of its terms and conditions by the User / Main User and/or any Affiliated User and/or any Commercial Team User and/or any Contractor or Consultant.
2. In case of violation of this License to Use by an Affiliated User and/or any Commercial Team User and/or any Contractor or Consultant, ASI reserves the right to authorize the User or the Main User and/or other Affiliated Users and/or Commercial Team Users, and/or Contractors or Consultants to continue using the ORIGINAL Product.

3. In case of the termination of this License to Use by ASI under paragraph 1 of this Article, the User / Main User, as appropriate:
 - a) shall have no rights to claim whatsoever and shall not be otherwise entitled to any compensation from ASI; in such a case, the User shall return or destroy the ORIGINAL Product and any of its copies and lose any utilization right over it;
 - b) must notify immediately ASI of the names of any Affiliated User and/or any Commercial Team User, Contractors and/or Consultants holding the ORIGINAL Product or parts of it and to request them to destroy any copy of it. The User / Main User shall be responsible for any action, omission and/or breach committed by its Contractors and/or Consultants and/or any Affiliated User and/or any Commercial Team User.

Article 9 – Completion of the License to Use procedures

The acceptance of this License to Use by the User / Main User shall be deemed to occur after the following steps:

1. Request for the User / Main User registration by downloading the License to Use, filling it with the personal data of: a) the User / Main User; b) any possible Team members involved with the use of the ORIGINAL Products (Affiliated Users and/or any Commercial Team User and/or Contractors and/or Consultants) declaring also the Purposes of Use of the ORIGINAL Products;
2. Filling the Project Form attached to the License to Use;
3. Uploading the completed License to Use through the PRISMA portal;
4. Declaring the acceptance of the Terms of this License to Use and the General Conditions, by clicking on the specific flag on the PRISMA portal; this operation has to be executed by the User / Main User which will in such a way take a personal and full responsibility about the correctness and completeness of the information entered in the License to Use;
5. Declaring if he authorizes or not ASI to send him by e-mail promotional material about PRISMA mission.

The User / Main User guarantees that the information and its personal data (as well as the personal data of possible Contractors, Consultants, Affiliated Users or Commercial Team Users) provided to ASI in this License to Use are correct and complete and so remain over time, therefore committing itself to communicate any updates if and when necessary. With the acceptance of this License to Use, the User / Main User assumes criminal and administrative responsibilities deriving from falsification of documents and incorrect, incomplete and/or mendacious declarations relating to the information entered into this License to Use. Should the User / Main User provide false, not updated or not complete information, or should ASI reasonably hold them as such, ASI reserves the right to suspend or delete the User's / Main User's account and/or reject any pre-existing request for ORIGINAL Product delivery.

Article 10 - Entry into Force, Duration and Amendments

This License to Use shall enter into force on the date of the completion by the User / Main User of the procedures specified in Art. 9 above and shall remain in force until terminated upon six (6) months prior written notice by one of the Parties. Any amendment to this License to Use (also deriving from the change of Affiliated Users and/or any Commercial Team User and/or Contractors and/or Consultants, in the Purposes of Use or Project Form) may be made only by written agreement between the Parties.

6. HOW TO COMPILE THE PROJECT FORM

The following section constitute the Project Form and shall be compiled by the User, filling up all the requested fields, including those of any Affiliated User (up to #10) and those of Contractor/Consultant (up to #5).

The next table list the categories of Users along with some example and notes. Please try to select in the Project Form the category who best resembles the one you belong to and use “Generic” only if you cannot adequately fit in the other categories. **Generic user shall always have the lowest possible privileges including missing capability to program the satellite for acquisitions.** Please don't use the “Special user” category unless agreed with ASI.

National categories are reserved for Italian citizens.

- The geographical areas of interest field shall contain the indication of at least one area
- The phone number shall include the international prefix in the form +NN and NOT 00NN (e.g. +39 and not 0039, in the case of Italy)
- Before uploading the compiled Project Form, rename the file as described below.
